ISO 18283:2006 defines the basic terms used in manual sampling of hard coal and coke and describes the general principles of sampling. The CPSR shall be conducted in accordance with this Guidebook, DCMA instruction 109, the Federal Acquisition Regulation (FAR) subpart 44.3, and the Defense Federal Acquisition Regulation Supplement (DFARS) subpart 244.3. A CPSR is conducted when a contractor's annual sales to the Government are expected to exceed \$50M in a 12 month period.

The sampling inspection schemes of parts 1, 2 and 3 of ISO 2859 and of ISO 8422 provide for quantification of the risks of accepting unsatisfactory product (known as "consumer's risk") and the risks of not accepting satisfactory product ("producer's risk") and for choosing a plan that allows no more risk than is acceptable.

### Sampling procedures for inspection by attributes

Attribute Sampling. The other form of sampling used by DCAA is attribute sampling. In attribute sampling, the selected sampling units are measured or evaluated in terms of whether they have the attribute of interest, and some statistic is computed from these measurements to estimate the proportion of the population that has the attribute.
