LABOUR MARKET AND EMPLOYMENT POLICY IN LEBANON

The Lebanese Labour Law is applicable to all workers and employers except domestic workers, agricultural workers, enterprises limited to family members and public servants.

Employers may legally hire, fire, suspend or discipline any employee at any time and for any reason - good or bad - or for no reason at all; however, an employer may not discriminate against any employee on the basis of the employee's race, sex, age, religion, color, national origin, or disability. Labor Laws - Tennessee

During the school year, their hours are limited to three hours on a school day and 18 hours per week. On days when there's no school and in the summer, working hours can increase to 8 hours a day and 40 hours per week. There are limits on when 14- and 15-year-olds can work, too.

What Are the Current Child Labor Laws and Regulations?

Child labor laws are contained in the Code of Virginia § 40.1-78 to § 40.1-116. In general, child labor laws are intended to protect the health and safety of children, to prevent exploitation, and to ensure that work does not interfere with their educational opportunities.
